Incomplete information will delay or disqualify your rebate. All rebate requests must be postmarked no later than January 15, 2019. Please allow up to six weeks for rebate processing. Did You Know?

A standard room air purifier, operating continuously, uses approximately 550 kWh per year in electricity. This is more than the energy used by some new refrigerators!
